# 1. Product and Company Identification

#### 2. Hazards Identification

Signal Word: Danger. Can cause irritation to eyes, skin and throat.



## SIGNS AND SYMPTOMS OF EXPOSURE (SKIN, EYE CONTACT; INHALATION; INGESTION)

EYE CONTACT: Causes irritation, damage, visual disturbances and possible blindness.

INHALATION: Can cause irritation to throat and respiratory tract. A burning sensation in the nose, throat as well as

coughing and choking may be noted. Continued deep inhalation may damage lung tissues.

*INGESTION*: Can cause nausea, vomiting, irritation to mucous membranes, esophagus and stomach.

SKIN CONTACT: Possibly severe irritation, burns. Long term exposure will cause dermatitis.

# 3. Composition/Information on Ingredients

#### 4. First Aid Measures

*EYES:* Immediately flush eyes with a directed stream of water for at least 15 minutes. Hold eyelids apart to ensure complete irrigation of all eye and lid tissues. Washing eyes within several seconds is essential to achieve maximum effectiveness. Get medical attention immediately.

*INGESTION:* If swallowed, DO NOT induce vomiting. If victim is fully conscious, give large quantities of water to drink. Never give anything by mouth to an unconscious person. Get medical attention immediately.
